

1. About this Privacy policy

This Privacy Statement is compliant with June 20th, 2018 French law n°2018-493 enacted June 21st 2018, which amended the French Data Protection and Freedom of Information Law of 6 January 1978 in accordance with General Data Protection Regulation (GDPR) (EU) 2016/679 from the European Parliament and Congress of April 27th, 2016.

The data controller is the « Ligue Nationale de Volley » (LNV), with registered office in Choisy Le Roi, 17 rue Georges Clemenceau, 94600. The LNV undertakes to respect and apply any obligations compliant with the GDPR.

Access to the Website is open and free, whilst the use of the Service and the access to some content on the Website is only allowed to registered users who have completed the registration form, and to users who have regularly paid the fees of Subscription and agreed to terms (terms of use).

2. Data that we collect and receive

The data that the LNV collects consists of:

- Data that you provide directly when you register for, or use, the Service. This data will vary, but typically consists of name, email address, postal address, phone number and other similar contact data.
- User credentials, such as username, password, password hints and similar security information used to create an account and authenticate users of the Service.
- Demographic data, such as age, gender, country and language preference.
- Usage data, such as the programs and features you access, items you purchase, and the timing, frequency and duration of your interactions through the Services.
- Device data, such as type of device, operating system, device settings and IP address.

If you connect your use of the Service through a third party service (e.g., a social media platform), the party may share certain information from your third party account with us.

3. Use of those Data

We use the data we collect for the following purposes:

- Operating our business. We use the data we collect to operate our business, including providing and improving the Service. Specifically:
 - To fulfill transactions that you request;
 - To deliver location-based Service and providing other customer support services;
 - To diagnose and fix problems with the Service and providing other customer support services;
 - For analytical purposes to better understand our fans and how they use the Service, which allows us to continually improve and expand the Service.

- Communicating with you. We use the data we collect to communicate with you, including responding to your requests or inquiries. Specifically:
 - To respond to your request if you contact us with a question or concern;
 - To provide information about your account, your use of the Service or other transactions that you request.
- Marketing and advertising:

To send you promotional messages and deliver advertisements about products, services, programs or events that may be of interest to you. Treatment of your data for direct marketing purposes is subjected to your optional and discretionary consent. You have the right to revoke any consent given for the processing of your personal data for marketing by sending an e-mail to this end to contact@lnv.fr.

- Security, compliance and enforcement:
 - To protect the safety and security of our users;
 - To detect and prevent abuse, fraud or other unlawful or unauthorized activities. It is important to remember that no system can be guaranteed to be 100% secure. We recommend that you help us keep your data safe by taking reasonable steps such as keeping your passwords private.

The data processed for the primary purposes set forth herein may be communicated by Lega, respecting the specific security measures, to third parties of whom the controller may use for various services, included as service provider Laola1 Multimedia GmbH , holding companies and or subsidiary company, advisers and collaborators.

4. Storing Data

In accordance with the CNIL recommendations, personal data will be deleted or anonymized 3 years after the last network connection to the Service by the user.

5. Children policy

The Service is not directed at children under the age of 13, and our policy is to not knowingly collect personal data from children under the age of 13.
